<b>Price Structure</b>	Fixed supply charges <b>except for taxes and utility charges</b>
<b>Supply Price</b>	12.99 cents per kilowatt-hour for 12 monthly billing cycles from when the Account(s) are enrolled with the Utility.
<b>Statement Regarding Savings</b>	The Contract price may not always provide a savings.
<b>Incentives</b>	In connection with entering into this Contract you will receive a \$50 Gift Card upon successful enrollment. Cards are issued by Virtual Rewards Center. Valid email address is required for receipt of Gift card. Gift cards will not have cash access. For any questions about your Gift card, call our customer care team at 1-855-465-1244.
<b>Contract Start Date</b>	The Contract term will start after the Utility processes your enrollment.
<b>Contract Term/Length</b>	The initial Contract term will be (12) monthly billing cycles from the Contract start date.
<b>Cancellation/Early Termination Fees</b>	<p>You WILL incur an early termination fee of \$150.00, if you terminate the Contract early for any reason other than those outlined below.</p> <p>You will not incur an early termination fee if: (1) you terminate the Contract within the Guarantee Period, or (2) if you terminate due to a change of residence (a) within your current Utility service territory and you do not request a "Seamless Move" as explained in the Contract, or (b) outside of your current Utility service territory; or (3) are no longer eligible for service under your Utility's residential electric rate classes.</p>
<b>Constellation Renewable Product</b>	For the Initial Term of this Agreement, the electricity supply service includes renewable energy certificates sourced from wind and/or solar power generators within the United States in an amount equal to 100% of the Accounts' usage, over and above mandatory renewable portfolio or clean energy standard requirements for the state in which the Accounts are located, during the term of the Contract. The renewable energy is provided to you for your residential use only, and will not make you eligible for any tax credits or other third party subsidies.
<b>Renewal Terms</b>	You will receive one renewal notice at least 45 days prior to the end of the initial term and each subsequent renewal term. This renewal notice will provide a new fixed price for the renewal term, or new terms and conditions, and will also explain how to cancel if you do not choose to remain with Constellation. If you do not reply, we will continue to serve you at the renewal fixed price for the renewal term.
